EDI Summary – PLEASE READ

- 1. EDI stands for "Electronic <u>Data Interchange</u>". It is an established system of business rules that allow two or more trading partners to conduct business electronically from one system to another system.
- AscendTMS allows EDI connectivity with any other capable system to send or receive load tenders to or from any other EDI capable system.
- 3. EDI requires significant time to set up between the trading partners. It involves setting up the EDI module, mapping the data from your trading partner to your AscendTMS account, and certifying the connection.
- 4. The one-time cost for EDI setup and configuration is \$1500 per trading partner. This includes the EDI module, the EDI data-mapping work, all EDI testing with your trading partner(s), EDI certification with your trading partner(s), and training for your new AscendTMS EDI module.
- 5. The ongoing EDI maintenance cost is \$1.75 per load tendered to you, whether the load is accepted or rejected by you, billed monthly, with a \$100 minimum per month per trading partner. There are no other fees.
